

Yalvaç Law Cookie Policy

This Cookie Policy has been prepared by Yalvaç Law within the scope of Article 10 of the Law No. 6698 on Protection of Personal Data("**Law**") and the Communiqué on the Procedures and Principles on Fulfillment of Notice Requirement.

The purpose of this Cookie Policy is to inform you about the types of cookies, the processing purposes and how you can manage the cookies within the scope of processing your personal data automatically through the placing of cookies on your device.

For the cookies, other than the necessary cookies we use on our website, the consents of the users are obtained and the opportunity to remove their consent at any time is provided.

What is a cookie?

A cookie is a small data file, which the internet browser places on your device. The cookie's job is to notify the site that the user has returned. Cookies are useful because remember preferences and analyse how you use websites. Cookies alone cannot be used to identify you.

How does our website use cookies?

We use cookies for various purposes, such as to (i) remember your choices to store information about usage of our website, (ii) track users' movements around our website and use of the sit, (iii) understand how our website is used and (iv) enable you to use and browse the website securely and efficiently. Please notice that the data we collect is statistical and not personal.

Types of Cookies

The following cookies are used on our website according to the purpose of use.

Necessary Cookies: These cookies are necessary for the operation of our website. These cookies are first-party cookies and process personal data during the session. These cookies are used as mandatory to fulfill an information society service you have requested (e.g. remembering privacy preferences).

Performance and Analytics Cookies: These cookies are used for performance and analytical purposes which allow counting the visitors on our website and measure the traffic and are third party cookies. Accordingly, we can measure and improve the performance of our website. These cookies help us understand which pages on our website are the most popular and which are the least popular.



Purposes and Legal Grounds of Processing

Necessary cookies are required to be used to fulfill the information society service you have requested and the processing of personal data by these cookies are based on the Article 5/2(c) of the Law "processing of personal data of the parties of a contract is necessary, provided that it is directly related to the establishment or performance of the contract" and Article 5/2(f) of the Law "processing of data is necessary for the legitimate interests pursued by the data controller, provided that the processing does not violate the fundamental rights and freedoms of the data subject".

Performance and Analytics cookies are used by our business partners to profile your interests and to obtain general - statistical information. Your personal data collected through these cookies are processed based on the Article 5/2(f) of the Law "processing of data is necessary for the legitimate interests pursued by the data controller, provided that the processing does not violate the fundamental rights and freedoms of the data subject" and your consent in cases where you do not explicitly request the relevant information society service.

Data Subject Applications
